










Device Symbol



Top View Pin-Out





Pulse Power Dissipation




Derating Curve





I_C, COLLECTOR CURRENT (A) Fig. 3 Typical Base-Emitter Turn-On Voltage vs. Collector Current




Fig. 5 Typical Base-Emitter Saturation Voltage vs. Collector Current




Fig. 7 Typical Gain-bandwidth Product vs. Collector Current




Fig. 4 Typical Collector-Emitter Saturation Voltage vs. Collector Current





Fig. 6 Typical Capacitance Characteristics


